

## **ANNOUNCEMENT**

### **ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN**

*5 December 2018* - Mapletree Industrial Trust Management Ltd., as manager (the “Manager”) of Mapletree Industrial Trust (“MIT”), wishes to announce that it will issue 12,244,525 new units in MIT (“New Units”) at an issue price of S\$1.8612 per Unit pursuant to MIT’s distribution reinvestment plan (“DRP”) in respect of MIT’s distribution for the Second Quarter Financial Year 2018/2019 from 1 July 2018 to 30 September 2018 (the “2QFY18/19 Distribution”) on 6 December 2018.

The New Units will be credited by 6 December 2018 to securities accounts of MIT unitholders (“Unitholders”) who have elected to participate in the DRP. The New Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited (“SGX-ST”) at 9.00 a.m. on 6 December 2018.

The new Units will rank *pari passu* in all respects with the existing Units.

Following the issuance of the New Units, the total number of MIT Units in issue has increased from 1,886,752,801 to 1,898,997,326.

Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered addresses in Singapore to The Central Depository (Pte) Limited, will receive their respective entitlements to the 2QFY18/19 Distribution in cash on 6 December 2018.
