ANNOUNCEMENT

ISSUE PRICE OF NEW UNITS PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE BALANCE 4QFY18/19 DISTRIBUTION

30 April 2019 - Further to the announcement dated 22 April 2019 by Mapletree Industrial Trust Management Ltd., as manager (the “Manager”) of Mapletree Industrial Trust (“MIT”), in relation to the application of a distribution reinvestment plan (“DRP”) to the distribution of 1.37 Singapore cents per unit in MIT (“Unit”) for the period from 20 February 2019 to 31 March 2019 (“Balance 4QFY18/19 Distribution”), the Manager wishes to announce that the issue price of the new Units in MIT under the DRP is S\$2.0193 per Unit.

The issue price represents approximately 2% discount¹ to the adjusted volume-weighted average traded price² per Unit (“adjusted VWAP”) for all trades on Singapore Exchange Securities Trading Limited (the “SGX-ST”) for each of the Market Days³ during the period of 10 Market Days prior to and ending on the book closure date (“BCD”) on 30 April 2019.

The Notice of Election is expected to be despatched to all Eligible Unitholders⁴ on or around 7 May 2019. The Manager will announce further details about the despatch of DRP documents in due course.

¹ The issue price represents approximately a 2.5% discount to the volume-weighted average traded price per Unit for all trades on the SGX-ST during the period of 10 Market Days prior to and ending on the BCD.

² The adjusted VWAP is computed based on the volume weighted average traded price per Unit of all trades on the SGX-ST for each of the Market Days during the period of 10 Market Days prior to and ending on the BCD and subtracting the Balance 4QFY18/19 Distribution for each of the Market Days prior to the first day of “ex-distribution” trading.

³ “Market Day” means a day on which the SGX-ST is open for trading in securities.

⁴ “Eligible Unitholders” means persons registered as unitholders of MIT in the Depository Register as at 5.00pm on the BCD of 30 April 2019 and with Singapore registered addresses.
