### KEY MANAGEMENT CHANGES

- CHANGE OF CHIEF EXECUTIVE OFFICER AND EXECUTIVE DIRECTOR
- CHANGE OF CHIEF FINANCIAL OFFICER

30 May 2024 – Mapletree Industrial Trust Management Ltd., as manager (the “**Manager**”) of Mapletree Industrial Trust (“**MIT**”), wishes to announce the following key management changes with effect from 22 July 2024:

1. the resignation of Mr Tham Kuo Wei as Chief Executive Officer and Executive Director of the Manager;
2. the cessation of Ms Ler Lily as Chief Financial Officer and her new appointment as Chief Executive Officer and Executive Director of the Manager; and
3. the appointment of Ms Khoo Geng Foong as Chief Financial Officer of the Manager.

Mr Tham will relinquish his role as Chief Executive Officer and Executive Director of the Manager on 22 July 2024. He will be transferred to Mapletree Investments Pte Ltd (“**Sponsor**”) to assume new responsibilities with the Sponsor. The Board would like to thank Mr Tham for his leadership and valuable contributions to MIT since its IPO in October 2010, for which he was instrumental in the listing of MIT. Mr Tham led MIT’s expansion into the data centre sector in North America and Japan and was also pivotal in driving MIT’s development strategy to grow the Hi-Tech Buildings segment in Singapore.

Ms Ler will relinquish her role as Chief Financial Officer of the Manager and will assume the role of Chief Executive Officer and Executive Director of the Manager on 22 July 2024. Ms Ler has been Chief Financial Officer of the Manager since November 2011 for which she is responsible for financial reporting, budgeting, treasury and taxation matters of the Manager, MIT and their subsidiaries. Ms Ler has been central in the planning and execution of MIT’s growth strategy through the years. She was instrumental in maintaining a flexible capital management strategy to support MIT’s expansion plans.

Ms Khoo is presently the Head of Treasury of Mapletree Logistics Trust Management Ltd. (“**MLTM**”), the manager of Mapletree Logistics Trust (“**MLT**”) and is responsible for MLT’s treasury and capital management functions. Ms Khoo brings with her more than 15 years of experience in corporate finance, capital market transactions, treasury and hedge management as well as handling complex investment structures across various countries MLT has presence in. Prior to joining MLTM, she spent five years as an auditor at KPMG Malaysia where she covered various industries and was also involved in due diligence work.

These changes in key management personnel are part of succession planning for the Manager and would further enhance the depth of its management bench capabilities.
