ISSUE PRICE OF NEW UNITS TO BE ISSUED PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE 1Q FY24/25 DISTRIBUTION

Further to the announcement dated 24 July 2024 by Mapletree Logistics Trust Management Ltd., as manager of Mapletree Logistics Trust (“**MLT**”) (the “**Manager**”) in relation to the application of the distribution reinvestment plan (“**DRP**”) to MLT’s distribution for the period from 1 April 2024 to 30 June 2024 (the “**1Q FY24/25 Distribution**”), the Manager wishes to announce that the issue price of the new units in MLT (“**Units**”) to be issued under the DRP is S\$1.276 per Unit.

The issue price represents approximately 3.00% discount to the volume-weighted average traded price¹ per Unit (“**VWAP**”) or 1.75% discount to the adjusted VWAP² for all trades on Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) during the period of 10 Market Days³ prior to and ending on the Record Date of **1 August 2024**.

The Notice of Election is expected to be despatched to all Eligible Unitholders⁴ on **8 August 2024** for which an announcement will be issued accordingly.

¹ The VWAP is computed based on the volume-weighted average traded price per Unit for all trades on the SGX-ST during the period of 10 Market Days prior to and ending on the Record Date.

² The adjusted VWAP is computed based on the volume-weighted average traded price per Unit for all trades on the SGX-ST for each of the Market Days during the period of 10 Market Days prior to and ending on the Record Date and subtracting the 1Q FY24/25 Distribution of 2.068 Singapore cents per Unit for each of the market days prior to the first day of “ex-distribution” trading.

³ “Market Day” means a day on which the SGX-ST is open for trading in securities.

⁴ “Eligible Unitholders” means persons registered as unitholders of MLT in the Depository Register as at 5.00 p.m. on the Record Date of 1 August 2024 and with registered mailing address in Singapore.
